

# A303 Stonehenge: Amesbury to Berwick Down

Public consultation – 12 January to 5 March 2017

## What's this all about?

The A303 Stonehenge scheme is Highways England's proposal to upgrade the A303 past Stonehenge between Amesbury and Berwick Down and provide a bypass for the village of Winterbourne Stoke.



## Why is it needed?

The A303 links the M3 and M5 to create the most direct strategic route between the South West and the South East. This makes it vital for the economy of the South West as well as local communities along the route.

But there is a problem. Several sections of the road are single carriageway, causing congestion, delays and an increased risk of accidents.

One of these is between Amesbury and Berwick Down, where the A303 runs through the heart of the Stonehenge, Avebury and Associated Sites World Heritage Site, passing close to the stones themselves.

## What's the plan?

Our proposed solution is to build a 1.8 mile tunnel under the World Heritage Site past Stonehenge, a bypass for the village of Winterbourne Stoke and improve existing junctions between the A303 and local roads.

## What are the benefits?

Our proposed solution would:

- Boost growth across the South West
- Reunite the two halves of the World Heritage Site
- Reduce congestion for local communities, commuters, businesses and tourists
- Improve the quality of everyday village life in Winterbourne Stoke and relieve other local villages of rat-running traffic.
