
National Highways**Planning Act 2008****A27 Arundel Bypass****Notice Publicising a Proposed Application for a Development Consent Order****Non-Statutory Supplementary Consultation**

NATIONAL HIGHWAYS LIMITED of Bridge House, 1 Walnut Tree Close, Guildford, GU1 4LZ (“the Applicant”) proposes to make an application (“the Application”) under Section 37 of the Planning Act 2008 to the Secretary of State for Transport for a Development Consent Order.

The Application is for the proposed A27 Arundel Bypass; including a new dual two-lane carriageway extending approximately 8 km, located to the south of the existing A27. The new dual carriageway will re-join the existing A27 west of Tye Lane and east of the Fontwell (east) roundabout. At the eastern end, the new dual carriageway will re-join the existing A27 to the east of the new Crossbush junction (the Scheme). The Scheme aims to improve safety, reduce congestion by increasing capacity and protect the quality of the surrounding environment.

National Highways carried out statutory consultation in relation to the Application from 11 January 2022 to 8 March 2022. Having received feedback during statutory consultation, and after further investigations, National Highways is carrying out a supplementary consultation in relation to changes made to the Scheme. This non-statutory supplementary consultation is taking place from 16 November 2022 to 16 December 2022.

The Scheme is an Environmental Impact Assessment development (“EIA development”), as defined by The Infrastructure Planning (Environmental Impact Assessment) Regulations 2017. This means that the proposed works constitute development for which an Environmental Impact Assessment will be required. An Environmental Statement containing information about the likely significant environmental effects of the Scheme will therefore be submitted as part of the Application. During the January 2022 to March 2022 statutory consultation, preliminary environmental information was included in a Preliminary Environmental Information Report, which is available online at <https://nationalhighways.co.uk/our-roads/south-east/a27-arundel-bypass/> along with the rest of the statutory consultation materials.

Supplementary consultation

From **16 November 2022** to **16 December 2022**, we are carrying out a supplementary consultation on changes to the Scheme since statutory consultation.

Supplementary consultation materials comprise:

- **Supplementary Consultation brochure** – The supplementary consultation brochure sets out the proposed design changes to the Scheme, as well as an assessment of any changes to the environmental effects that may result from the changes, compared to what was presented previously. The brochure includes imagery from our general arrangement drawings to show the key areas where design changes to the Scheme have occurred since the statutory consultation. It also takes the opportunity to clarify certain aspects of the Scheme proposals.
- **Feedback form** – Available in hard copy format and online, this feedback form is for people to provide their feedback on the proposed changes the Scheme presented as part of the supplementary consultation

- **Walberton Traffic Mitigation Assessment technical note** – This document offers further information and detail on our proposals to mitigate against a predicted increase in traffic along The Street in Walberton.
